- 4. Tenderers who possess relevant experience and proven track record of having successfully completed services of similar nature and meet the Mandatory Requirements by submitting the proof of registration, experience and compliance to the minimum qualification requirements as stated below:

 (a) Local Consultant-registered with:
 - (i) Ministry of Finance, Malaysia under Code 330207 and/or 330208 and/or Pejabat Setiausaha Kewangan Negeri Sarawak (UPKJ) and
 - (ii) Natural Resources and Environment Board Sarawak (NREB), Competent Personnel registered with Department of Environment (DOE) Malaysia and experienced in Environmental Consultancy Services; and
 - (iii) Companies Commission of Malaysia (SSM) and/or Registrar of Businesses (ROB),
 - (b) Minimum combined paid-up capital in Ringgit Malaysia: One Hundred Thousand (RM100,000.00) (based on the latest financial year).
 - (c) Average net profit for the last three (3) years (2018, 2019 and 2020) shall be positive with minimum two (2) partners MUST be positive including the Lead Partner.
 - (d) Minimum qualification requirements:
 - (i) Must be established at least ten (10) years in providing Environmental Consultancy Services;
 - (ii) The Project Director/Project Manager must have at least ten (10) years of experience in providing Environmental Consultancy Services;
